The final email will confirm acceptence or notify you of any issues that must be corrected. Once corrected please submit a copy of the corrected abstract(s) and/or write-ins certification(s) via a new formsite form.

Do <u>NOT</u> mail your original abstracts, write-ins certifications, and certification checklist until after ELECT has confirmed acceptance of the data entered in Enhanced Results and documents submitted via this form.


